You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Sub-Fund is part of ALTEX fund. The Depositary is Quintet Private Bank (Europe) S.A.

Term

The investment horizon is medium term and should be at least 5 years.

Objectives

The investment objective of the Sub-Fund is to achieve long term capital appreciation and preservation by investing in a concentrated portfolio of high-quality equities, while seeking to contain volatility and risk with complementary currency and beta hedging strategies.

While respecting the principle of risk diversification, the Sub-Fund's assets are invested mainly in equities and equity linked securities and derivatives without restrictions on economic sector or geographic origin with a flexible beta exposure: as market conditions change, the portfolio exposure to equity, and consequently, its beta exposure, will also vary. The Sub-fund's investment strategy is implemented with a global and pragmatic approach to equity markets. It requires active multi-asset management and dynamic risk control to contain portfolio volatility while preserving an attractive return for investors.

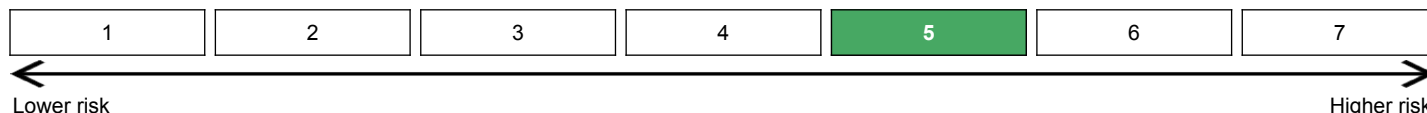
Bottom-up investment decisions are the result of a disciplined selection process that combines fundamental analysis, return stability, business visibility, risk assessment and momentum awareness. This stock picking process includes several phases. The first phase is executed on a quarterly basis, using the Management Company's proprietary quantitative filter: the financial data (sustainable growth of fundamentals, financial strength, and long-term momentum, among others) of these companies is automatically screened, and an internal scoring is assigned to each name. As a second step, an in-depth discretionary analysis of those companies with a scoring meeting the Management Company's criterion (usually around 150-300 companies) is performed to build the Sub-Fund's investment target universe.

Intended retail investor

Class of Shares A is open for subscriptions by both retail investors and Institutional Investors, Professional Investors and investors receiving advisory services or discretionary investment management services as defined by the MiFID II Directive, and having separate fee arrangements in relation to those services and activities.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class.

Unfavourable scenario: This type of scenario occurred for an investment between December 2021 and December 2022 (If you exit after 1 year), December 2017 and December 2022 (If you exit after 5 years).

Moderate scenario: This type of scenario occurred for an investment between July 2017 and July 2018 (If you exit after 1 year), December 2019 and December 2024 (If you exit after 5 years).

Favourable scenario: This type of scenario occurred for an investment between March 2020 and March 2021 (If you exit after 1 year), October 2016 and October 2021 (If you exit after 5 years).

What happens if ALTEX Asset Management S.G.I.I.C. S.A. is unable to pay out?

The investments of the fund are held separately from the assets of ALTEX Asset Management S.G.I.I.C. S.A. as fund management company and from the corresponding custodian bank. Thus, you will not lose your investment in the event of a possible insolvency of ALTEX Asset Management S.G.I.I.C. S.A.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

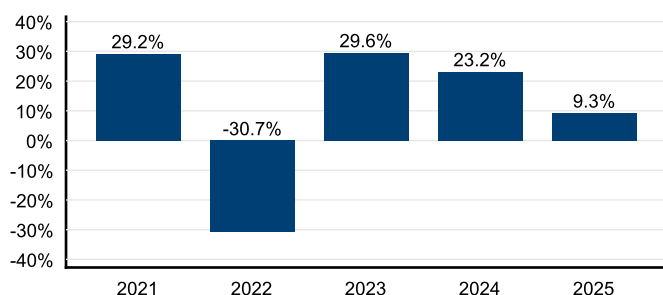
